


WHAT IS IT? A document automation tool.


WHAT IS IT? A document automation tool.


WHAT IS IT? A drafting tool.

### **STRUCTURE FLOW**

WHAT IS IT? A visual diagramming tool.

WHEN COULD IT BE USED?

To help quickly produce, present, and share structure diagrams, transaction structures and steps plans. These can be exported for use within other documents such as Microsoft Word or PowerPoint or as a PDF.

### WHEN COULD IT BE USED?



WHAT IS IT? A proof-reading tool.


WHEN COULD IT BE USED?

To check a document in Word for errors e.g. cross references, defined terms, numbered lists, inconsistent phrases and editing mistakes, and also to check for errors in citations of case law and legislation.

#### WHAT IS IT?


Al due diligence review tool which speeds up contract reviews by recognising and identifying document and clause types in a large document set.

### **VIRTUAL DATA ROOMS**


WHAT ARE THEY? Online repositories for storing documentation.


WHAT ARE THEY? Al review tools which speed up the review of electronically stored information.


WHAT IS IT? Al due diligence review tool.

An e-signature tool for use when an external parties signature is required.


#### WHEN COULD IT BE USED?
