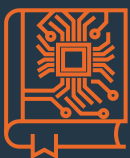
### Human-Centric Problem Solving

Legal teams are often asked to advise on problems facing the business. We consider the key methodologies which can be employed to help teams work smarter when approaching problem solving. We will cover problem solving and continuous improvement, Design Thinking and LPD at Slaughter and May from the view of the client or end user.



### Process Design: Train the Trainer

We explore our five-step LPD methodology to achieve the end goals; taking a deep dive into the Process Map which is one of the key outputs of the LPD methodology. We will then explore how to run an effective LPD workshop focusing on preparation, agenda, facilitation and challenges.

## Legal Project Management
